# How do I get started?

Register on our web-app. Instantly receive log-in credentials and start trading!

We believe that an easy-to-use application with an amazing experience allows traders to focus on what's really important.

Step 1: Register for the app

Step 2 PC: Click on the Start trading button in the top right corner of your dashboard.

Step 2 Mobile: Click on the Start Button in the menu, select start trading, choose the account type you wish to trade, sign up and receive your credentials immediately.

# Is verification required?

Yes, all traders must go through our double verification system.

First, You have to go through verification in your dashboard.

During this verification, you need to provide a valid document that is accepted by Veriff and take a picture of yourself. Thanks to this verification we can check if the account is truly used and operated by the existing person. This usually takes only a few minutes.

Then after you pass our evaluation process, you need to sign the contract of the funding account. For this account verification, we require the same documents as you have used for Veriff verification. It can be a passport, ID, or driver's license. We do not require any proof of address and Veriff also does not. This verification may take up to 24 hours.

*The verification is not required right from the beginning. However, you will be able to pay only with cryptocurrencies, and eventually, you will have to go through Veriff if you wish to receive a funded account.*

# Do I need a license to trade?

No, you are always trading on a simulated account so you do not need a license to trade. Just sign up and trade. If you successfully complete any of our evaluations, we will provide you with account that you can earn from. Simply sign the contract we send you with valid information and we will get you all set. However, please note that you are responsible for your own taxes in your own jurisdiction.

# How do I apply to become a Funded trader?

What's the evaluation process?

Simply choose the account type you are interested in trading, follow the steps necessary to complete the application and after we receive the payment, your account will be issued ( you will find it in your Funded dashboard) and you will get an email with confirmation.

You will have realistic account conditions in the form of low commissions and spreads. If you manage to pass all requirements in the phase one of the account evaluation, you will proceed to the second and the final phase of the evaluation and you will receive a new account for the step two and three where the rules will be significantly easier during this final stage before the funding.
